MANY OF THESE YOUTH HAVE BEEN ABUSED OR NEGLECTED AND COME TO US FROM THE FOSTER CARE SYSTEM. OTHERS HAVE COMMITTED NONVIOLENT CRIMES AND OUR PROGRAM OFFERS A SUPPORTIVE, THERAPEUTIC ALTERNATIVE TO JUVENILE DETENTION. THE CAMPUS PROVIDES THE BROADEST CONTINUUM OF SPECIALIZED RESIDENTIAL CARE AVAILABLE IN NEW YORK STATE.

OVER THE YEARS, THE CRISIS RESIDENCE HAS CARED FOR HUNDREDS OF CHILDREN, WITH POSITIVE OUTCOMES. OFTEN YOUTH RETURN HOME IN LESS TIME THAN IF THEY HAD GONE TO A HOSPITAL, WITH LESS MEDICATION, NO RESTRAINTS, AND AT LESS THAN HALF THE COST. WITHIN CHILDREN'S VILLAGE CAMPUS ENVIRONMENT, WE OPERATE A SPECIAL PROGRAM SPECIFICALLY FOR BOYS WITH SERIOUS EMOTIONAL PROBLEMS. THIS PROGRAM, WHICH IS HOUSED IN BROOKS COTTAGE ON OUR DOBBS FERRY CAMPUS, FEATURES A STRUCTURED AND ENRICHED DAILY SCHEDULE AND A HIGH LEVEL OF PROFESSIONAL AND CLINICAL
