
I am excited to share details about two significant accomplishments that, as of this writing, are days from completion:

First is the finalization of Inwood House's merger with The Children's Village, which we have been working toward for 18 months. The organization brings to us cutting-edge teen leadership, pregnancy prevention education, and support for pregnant and parenting teens. The second accomplishment is the opening of a 10-story building at 2139 Adam Clayton Powell Jr. Blvd. in Harlem that provides 48 affordable one- and two-bedroom apartments, program space, and, most exciting, 12 studio apartments on the ninth floor and penthouse for young adults aging out of foster care. ## Building Brighter Futures

Every day there are children who wake up alone, with no adult who loves them unconditionally. These are often the same children who drop out of school, run away, or get in trouble with the law. Many end up on our streets, in homeless shelters, or in prisons. Unless we intervene.

With your help, we find critical lifelong connections for children, help them understand that their lives have possibilities, and support them in developing the skills and attitudes to succeed.

We operate more than 25 different programs that fall into one of three areas:



Prevention:

### Children belong to families, not to charities, programs, or the government

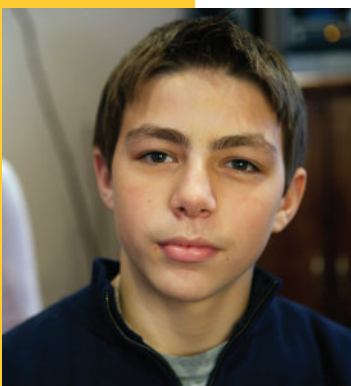
Much of what we do is aimed at keeping children out of our residential programs. We support stressed families by helping them stay together and keep their children home—out of foster care, residential care, and even detention. Our staff work with families in their homes using a variety of short-term, evidence-based strategies designed to have long-term success.



Residential:

### Sometimes children and teens need time away

Staying at home is not always possible, or advisable. Sometimes children need to be protected from an abusive situation or spend time away from negative peers so they can get back on track. We provide a variety of safe, short-term programs that give children and teens the opportunity to learn new coping skills while our staff work with their families or find new connections to ensure their safe return to the community.



Aftercare:

### Returning home is not always easy

When struggling teens leave residential programs or incarceration, they need support to be successful. Often a little help from our mentors goes a long way in maintaining optimism and making the transition work. We help them build the skills they need to succeed, focusing on education, work readiness, and the ability to take charge of their lives and their futures.

## Stronger Together

Inwood House, a respected New York City organization, is now part of The Children's Village. We are pleased to welcome Inwood House programs, staff, and children to the CV family.

### Some Background on Inwood House

Established in 1830, Inwood House has been the only organization focused on providing comprehensive services to pregnant and parenting teens and on pregnancy prevention education. Programs include:

#### School Programs:

Teen Choice – Provides sex education, leadership development, and parent outreach. Teen Choice is in more than 20 schools in New York City.

PRIME Leaders – A comprehensive program in public schools in the South Bronx designed to train and facilitate young leaders.

#### Residences:

Boarding Homes – Two small homes for teen moms and their babies.

Supported Housing – Residence for runaway and homeless girls, including pregnant and parenting teens.

Shelter – Short-term shelter for runaway and homeless girls, including pregnant and parenting teens.

#### Community Support for Parenting Teens:

Continuum of Care – Workshops and support services to prepare teens to live independently and care for their children.

### Facts About the Merger

#### *How does the merger affect Inwood House programs?*

All programs will continue as part of "Inwood House at The Children's Village," a separate division that retains the IH brand and expertise in pregnancy prevention and care for pregnant and parenting teens.

#### *What are the advantages of the merger for CV?*

It expands our presence in the communities where struggling families live and enhances our ability to serve teens in our programs who are struggling with parenthood.

#### *What about the Inwood House Board?*

The IH and CV Boards have worked closely together on the merger, and some IH trustees will join the CV Board. IH's active Corporate Advisory Board will continue to support IH and now will work with CV as well.





## You Made it Happen

Whether you made a financial contribution, donated your time, or provided gifts for children and families, you made great things happen for the people we serve.

In fiscal year 2016:

93%

611 eligible children remained with or returned to families.

Savings: \$19.5 million

The annual cost of out-of-home care is from \$32,000 (foster care) to \$140,000 (residential care) per child.

100%

98 teens on probation stayed out of detention or jail.

That's 100% of the teens we worked with in our community programs -- compared to only 45% of teens statewide who avoid re-arrest.

Savings: \$34.5 million

According to the Justice Policy Institute, New York has the highest annual cost for juvenile incarceration, at \$352,663 per child.

98%

43 formerly homeless teens are now living in stable housing.

That's all but one of the young people who were in our transitional living programs.

Savings: \$737,536

According to a study sponsored by YouthLink, each homeless teen costs taxpayers \$17,152 per year.

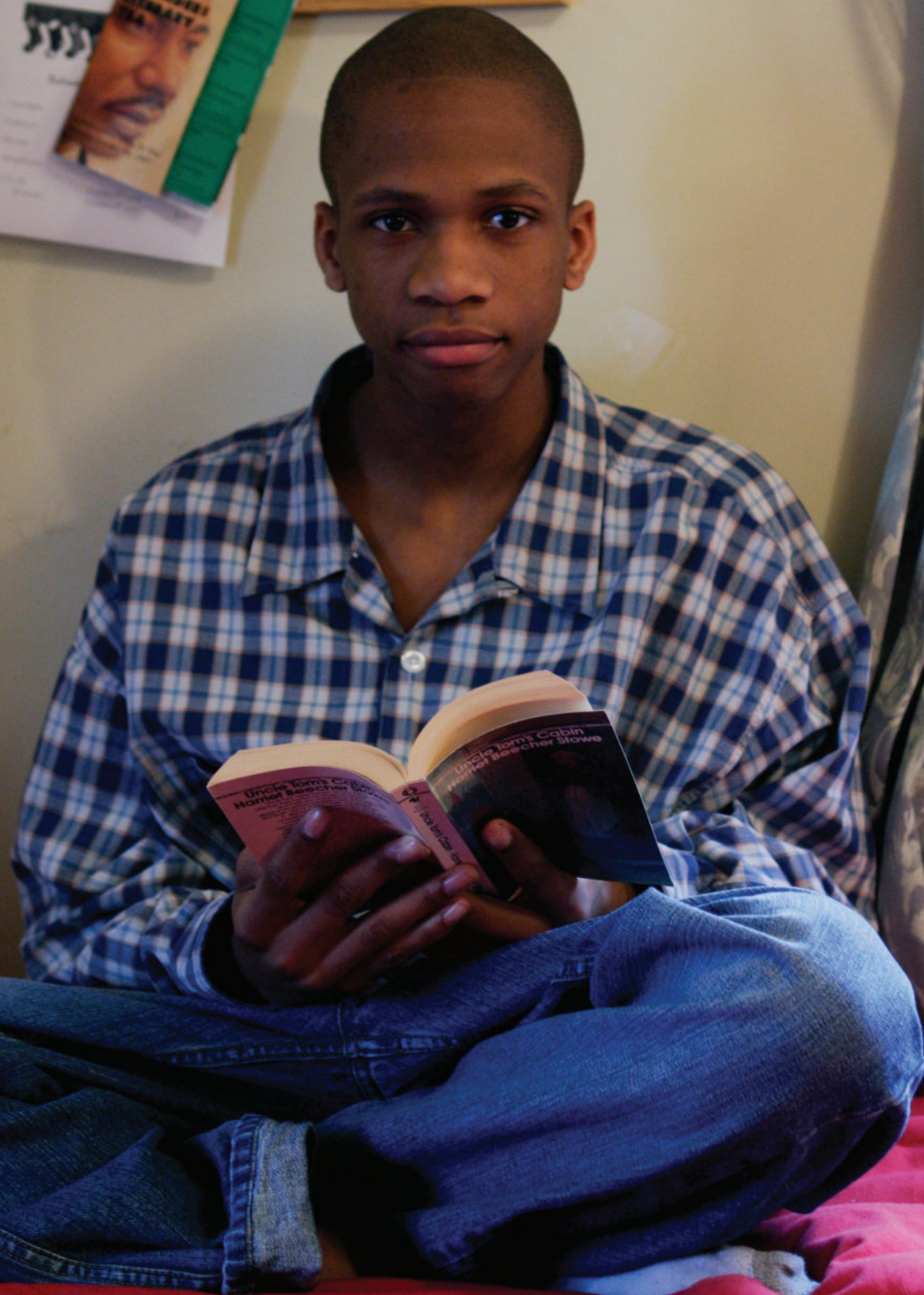

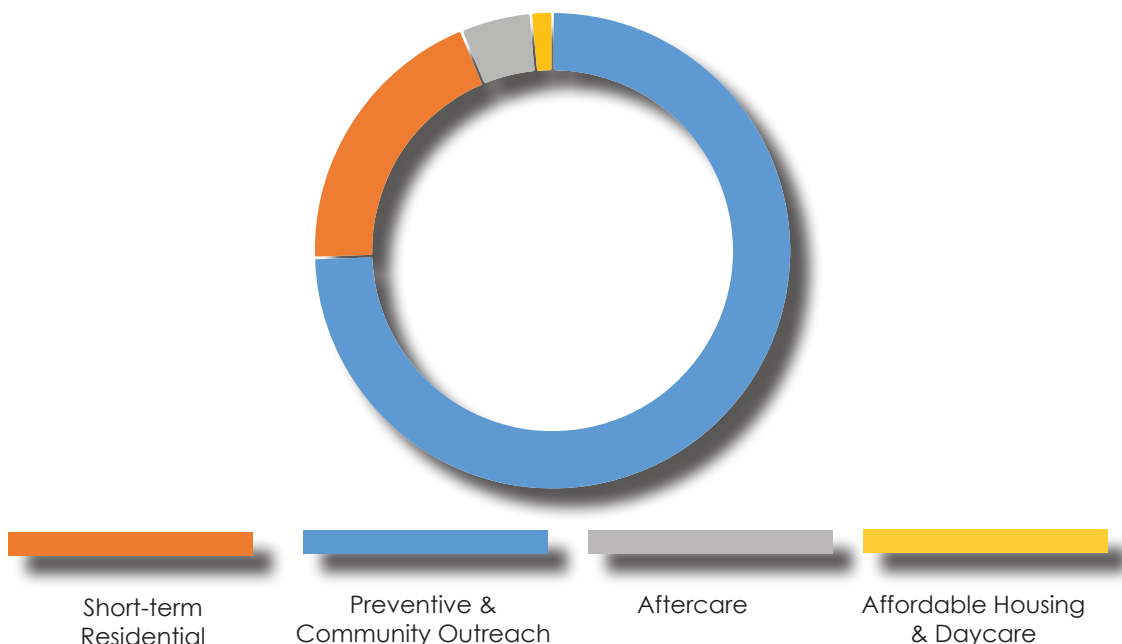
