The Sanctuary offers a safe haven for vulnerable young people in Westchester County. Teens in crisis come from every town in Westchester, often running from an abusive situation or life on the streets. Your generosity will give hundreds of youth a safe place to sleep, a hot meal, and a chance to get their lives back on track. On behalf of all of them, thank you!

The *Sanctuary* at work:

- ◆ After 5-months of living on the streets, J.C. came to the Shelter for help. The first couple days were really rough. She was malnourished and depressed, but had made the first step toward getting her life back. Staff took her to a doctor, helped her with nutrition, enrolled her in school, and helped her deal with the issues that caused her to leave home. Today, J.C. is in school and passing her classes and, most importantly, reunited with her family.
- ◆ Late last spring, a brother and sister, Jeff and Amanda, were admitted to the Sanctuary through their school guidance office after being abandoned by their parents. Working with Social Services, shelter staff was able to locate other family members in Westchester who took them into their home. Jeff and Amanda are now doing well living with their relatives, who are committed to caring for them.
